4.0 MCLE CREDITS: 3.0 Ethics ; 1.0 Areas of Professional Practice/Law Practice Management.

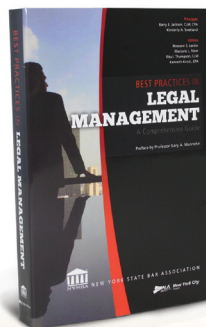
